On November 8, a new Jesuit Retreat Center Advisory Board had its initial meeting. The eighteen members, women and men rooted in the Ignatian spiritual tradition and in the life of the Retreat Center, bring to the service of the JRC wide professional experience. The Board will assist Fr. Tom Carroll with the development of the Retreat Center and its ministry.

The Advisory Board resumes an early Retreat Center tradition. The founding of El Retiro in 1925 was inspired by the Laymen's Retreat League then active in the Bay Area. Having the League's encouragement and support, the Jesuits made their commitment to the ministry of the Spiritual Exercises here. The League Board played an integral role in the Retreat Center through the first decades of its history.

Over recent decades, the retreat and training offerings of the JRC have become more varied and our constituency more diverse. Given the new opportunities at this point, Fr. Carroll and Fr. John McGarry, S.J., Provincial, want to engage again the collaboration of an Advisory Board. The wisdom of our friends on the Board will expand our vision and creativity as we plan toward the future of the JRC.

Bequests: Since the last issue of the JRC News, we have received from the estate of **Aidan A. Shea**, \$5,000; from the **Arthur J. Mott Trust**, \$37,111.90; and from the **Betty Morgan Johnson Trust**, \$29,840.51.

St. Joseph's Corner

From a variety of projects addressed since the last JRC News, a few highlights:

Rossi Chapel has a new look. The sanctuary is edged in contrasting carpet, similar to the burgundy of the chairs, to make the step more evident. The addition of spots on altar and ambo and of twelve new floods on the assembly—and, perhaps more importantly, on their (now larger-print) song books—has shed new light on our liturgy.

Work at the south porch of Loyola continues. The porch is again level and safe. Our crew has re-aligned the porch roof and re-attached it to Loyola, replacing the original nails with quite substantial bolts. Next, they will install new retaining walls, with French drains, preparing a gracious new entrance to the offices of the Jesuit Institute for Family Life, just below the porch.

Work on the walk leading up to the dining room entrance to Pereira has been put off, as the sinking of the walk is related to the lack of drainage in the central courtyard. Another effect of that lack is occasional basement flooding (yes, the water comes right through the concrete walls) in Pereira and Loyola. A drainage project will soon be in the works.

Dear Retreatants and Friends,

2007 has been a year filled with God's blessings for the Retreat Center. We are happy to be able to share with you in this Annual Report some reflections, and some statistics, on the year. As usual, the Donor List will record the gifts we have received during the calendar year 2007. The other statistics will reflect the fiscal year which concluded on June 30, 2007.

Weekend and weekday retreats continue to draw a spectrum of people seeking to know God more deeply and to live their Christian discipleship in greater authenticity. Once again, high school retreats accounted for our largest constituency—the hope of the future! We hosted two retreats for the homeless in 2007, our third for men and our first for women, and a second for homeboys. Helping the participants to imagine and to choose good futures for themselves is a great grace. The Pierre Favre Program, now in its second year, prepares lay people and Jesuits together (twenty participants, all told) to give the Spiritual Exercises, the fundamental Ignatian experience.

The Province sent Fr. Kevin Ballard to join our retreat team just after Easter, for his second tour of duty at the JRC. We are grateful that the Province so generously invests its human and financial resources in the ministry of the Exercises here. We are grateful, as well, for the generosity of the members of our new Advisory Board, introduced on the first page of this issue, who will be sharing their wisdom and experience for the benefit of the JRC.

The support of our benefactors remains essential to the development of the ministry here, just as that support has sustained us since 1925. I am most inspired by the enthusiasm of many of our benefactors for extending the opportunity to share in retreat experiences to others. Many who might otherwise not have access to the blessings of retreat do have such access because of your generosity.

Again, I thank you, our benefactors, on behalf of the Jesuit Retreat Center staff and on behalf of our many retreatants who benefit from your kindness. I thank, as well, our Retreat Captains and our team of volunteers for their essential assistance in many phases of our ministry. You are all remembered and cherished here in prayer, particularly in each Wednesday afternoon Mass in Rossi Chapel. All God's blessings!

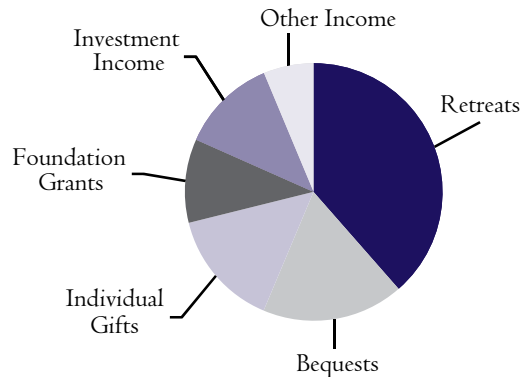

Footnotes

¹ These individual gifts include contributions from a number of Jesuit sources, of which \$191,144.74 was given by the Jesuit Community of the Jesuit Retreat Center of Los Altos. (Salaries have long been established for the members of the Jesuit Community on staff at the Retreat Center, now numbering seven. These salaries totaled \$357,228.00 in fiscal 2006/07. Through the kindness of the Provincial Superior of the California Province of the Society of Jesus, the Jesuit Community has been allowed to donate back to the Retreat Center each year the bulk of its surplus income. Jesuit Community payments to the Retreat Center, for rent, meals, and other Community expenses, are included in the summary above.)

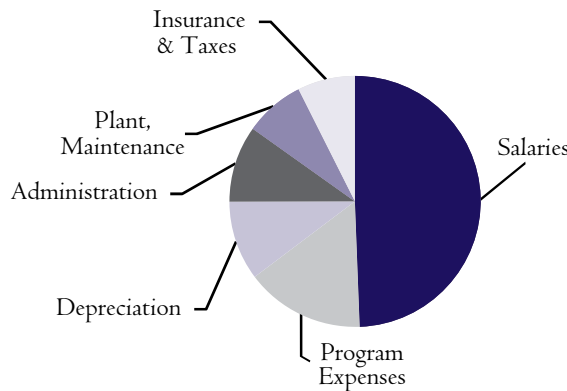
² Forestry work over the course of the fiscal year, involving an asset transfer of \$255,505.00 from the endowment, was capitalized as an improvement to the land.

³ The Retreat Center's full-time staff includes seven Jesuits and 28 lay people. Regular on-call staff occasionally assists in housekeeping and food services.

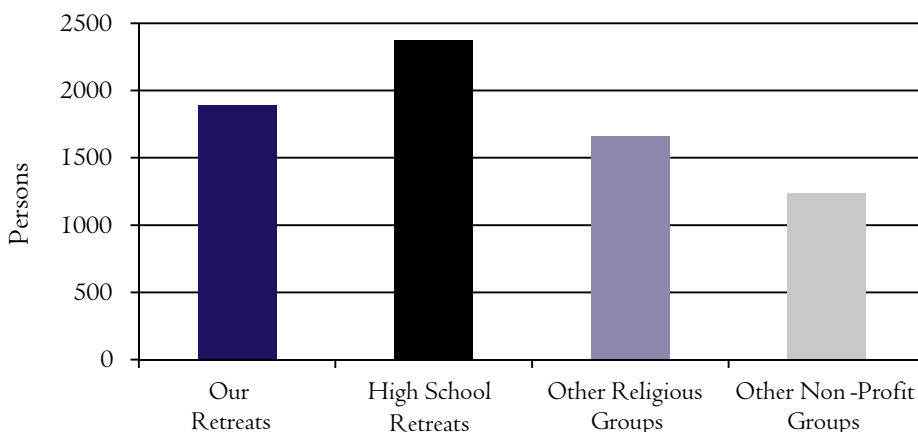
⁴ Most of our guests stay for two days or more, some as many as 36 days.

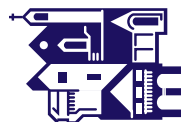
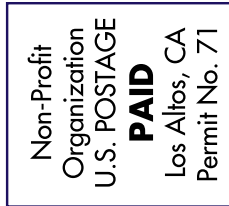
